13:15 – 14:05	<i>Panel Discussion II</i> Cardiovascular Health & CVD-Plans and Investments in Eastern European Countries Cardiovascular disease (CVD) remains the leading cause of death in Europe, causing 36% of all EU deaths and affecting 60 million people. Despite a decline in CVD mortality over the past 50 years, heart attacks and strokes still predominate. In the broader European Region, CVD accounts for 47% of deaths in women and 39% in men, with significant disparities between Eastern and Western Europe.
